



ES/LW 351 INTRODUCTION TO INTERNATIONAL ENVIRONMENTAL LAW: A EUROPEAN PERSPECTIVE

IES Abroad Freiburg

DESCRIPTION:

This course offers a comprehensive introduction to principles and mechanisms of international environmental law, examining how legal tools and governance structures address environmental challenges at global, European and national levels. The course is divided into two complementary parts. The first part lays the groundwork for understanding international environmental law and governance, focusing on key principles, legal instruments, and the roles of major actors such as national governments, international organizations, and non-governmental organizations. Special attention is paid to the European Union's pioneering environmental regulations and ambitious green strategies as well as Germany's national and subnational environmental regulations, illustrating the interplay of governance efforts across different levels. The second part applies these foundational concepts and principles to case studies, offering an in-depth analysis of the challenges associated with formulating and implementing international and EU environmental law. Students will examine legal responses to pressing issues such as biodiversity loss, wildlife conservation, marine protection and sustainable forest management.

Designed for students without a legal background, the course presents key legal concepts and principles in a clear and accessible manner. Students will not only gain a strong understanding of international and European environmental regulations but also develop the analytical skills needed to critically analyze case studies. Additionally, students will enrich their learning experience through interactions with EU officials and national experts during course-related trips, offering firsthand insights into the environmental initiatives at both the EU and national levels.

This course is embedded in the EU Program: Law, Economics and Politics, which is an interdisciplinary program focusing on key actors, complex policymaking processes, and multilevel governance structures within Europe, as well as the EU's dynamic role in the international system. Course-related trips are a distinctive feature of the EU Program and provide a unique opportunity to connect in-class academic learning with practical experience. As part of the broader EU Program, students will visit key EU institutions in Brussels, Strasbourg and national institutions in other European cities, where they engage directly with policymakers, legislators, and civil society actors in structured meetings that provide firsthand insight into EU decision-making processes at the European and Member State levels. These lectures offer invaluable exposure to EU decision-making processes and bring to life the complex realities of environmental governance.

In this context, by focusing on the EU's pioneering role in environmental legislation and its ambitious green transition strategies, the course offers students critical insights into how the EU shapes global norms and responds to transnational challenges. In connecting classroom learning with direct engagement with experts at European institutions, the course strongly supports the program's commitment to experiential learning and provides students with a nuanced and practical understanding of the EU's environmental leadership. PREREQUISITES: One college level course related to international relations, environmental studies, or environmental politics.

METHODS OF PRESENTATION: discussion of readings, case studies, group work and presentations; talks by academics and practitioners including meetings with policymakers and other relevant actors during course-related trips.

Course Participation:

Students are expected to complete all assigned readings and actively contribute thoughtful insights during in-class discussions. There are also recommended readings for each session, which are intended for students who wish to deepen their understanding of the session topic. Questions based on the required readings will be posted on Moodle prior to each session, and students are required to respond to them. These components will collectively determine the class participation grade. Participation also extends to meetings during course-related trips as well as to local field trips in Freiburg.

Midterm Exam

(90 minutes) The midterm (session 8) will be held after the end of the first part of the course and focus on the contents of the required readings, lectures and the in-class discussions. It will consist of two essay questions, one of them may include reflection on the local field trip meeting. More detailed guidelines and a grading rubric will be provided on the course Moodle page.

Group work and role-play

In this assignment, students will participate in a role-play exercise based on a fictional case study related to the topics



covered in previous sessions. Topics may include deforestation, pollution, or protection of biodiversity. For instance, a renewable energy company establishing a wind power plant in the Black Forest where some special bird species might be under protection. The course instructor will provide the case study details and general prompts for each role in Session 8. Each group must develop arguments that reflect the interests and perspectives of their assigned role, using the principles of environmental law covered in the first part of the course and relevant case law discussed thus far. Students will be organized into small groups of 3-4 members, each representing different actors in environmental law and their respective interests.

The allocation of groups and roles will be determined by a random draw at the end of Session 10. One group will represent a non-governmental actor (e.g., an NGO), another group will represent a governmental actor or a State or a company, and the last group will act as the judge of the competent court. Since this exercise consists of a simulated trial, students will be required to construct a legal argument defending their cause and the interests they represent. They will then present their arguments before the court, which will be responsible for resolving the dispute. Therefore, students will need to meet outside of class to conduct research and prepare their arguments together as a group.

Each group is encouraged to ensure that the oral presentation of their argumentation is divided into multiple parts so that each student has the opportunity to speak. Additionally, the prepared argument must be written and submitted to the instructor in advance. While the group of students representing the judges will deliver a verdict at the end of the pleadings, the evaluation will focus solely on the quality of the arguments presented by each student. Additional guidelines and a detailed grading rubric will be made available on Moodle.

Critical Writing Assignment and Presentation

Each student will complete a critical assignment of 2,500 – 3,000 words (20%) and present their findings in class (10%). Students may choose to write about either a general principle of environmental law or a protected species (with the exception of wolves and whales). Students are expected to explore historical and legal origins of either the general principle or the protection of an endangered species, examine examples of applications or relevant case law both from European and international environmental laws, and provide a critical analysis of its effectiveness and implications in different EU Member States.

Regardless of the chosen topic, students are expected to demonstrate their analytical skills to argue and defend a legal position in environmental law effectively. The critical writing assignment is due by Session 15, while the presentations will be held during Session 17. Additional guidelines and a detailed grading rubric will be made available on Moodle.

Final Exam

The final exam (Session 19) will be comprehensive in nature. In 120 minutes, students will write two essays covering topics from the entire course. Questions will also require reflection on the course related trip meetings. Detailed instructions on the exam content will be provided in advance, with additional guidelines available on the course Moodle page.

**LEARNING OUTCOMES:**

By the end of the course students will be able to:

- define key concepts of international and European environmental law;
- demonstrate knowledge of international and European governance structures regarding environmental law;
- identify various actors at international, European, and national levels that are involved in climate protection and the legal frameworks they operate within;
- construct well-reasoned legal arguments based on a case study and its respective legal framework;
- develop a comparative perspective on existing environmental regulations at national, European and international levels;
- critically analyze key challenges of the legal instruments, assessing their strengths, weaknesses, and effectiveness;
- explain the impact of international law, with a particular focus on the European Union's environmental regulations on national law and policies.

ATTENDANCE POLICY:

All IES courses require attendance and participation. Attendance is mandatory per IES Abroad policy. Any unexcused absence will incur a penalty on your final course grade (1 absence - 1%, 2nd absence -2%, 3rd absence – 3%). Any student who has more than three (3) unexcused absences will receive an “F” as the final grade in the course. Any student who misses more than 25% of a course, whether the absences are excused or are unexcused, will receive an “F” as the final grade in the course. Absences due to sickness, religious observances, and family emergencies may be excusable at the discretion of the Center Director. COURSE-RELATED TRIPS:

- Franco-German History Trip:** Alsace, France – 1 day
 During the first course related trip you will visit two significant historical and cultural landmarks in Franco-German history. You will have guided tours and learn about how age-old controversies and catastrophes in the heartland of Europe are represented, the role of memorials in constructing a European identity, and the challenges of overcoming centuries of conflict and rivalry.
- Germany in Europe: Then and Now Trip:** Berlin, Germany – 5 days
 During the course-related trip to Berlin, you will continue to learn about the past and present of German culture, economy and politics of Germany. Historically this capital is a crucial place if one wants to understand the importance German politics has for the dynamics of European integration. In Berlin you will learn about the fall of the Berlin Wall, the reunification of Europe after the end of the Cold War, the challenges that emerged during the process of post-communist transition and about Germany’s hegemonic position within the EU.
- EU Parliament Trip:** Strasbourg, France – 1 day
 During this one-day trip, which is thematically linked to the EU Institutions trip you will visit the European Parliament in session in Strasbourg, France. There you will attend the parliamentary session and meet a



Member of European Parliament who will discuss current events and elaborate on the workings of the European Parliament.

- EU Institutions Trip: Brussels, Belgium and Paris, France – 7 days

This course-related trip will take you first to Brussels, the EU's institutional power center. In Brussels you will have the opportunity to meet with not only EU officials but also representatives of national delegations to the EU, think tanks and NGOs, as well as academic experts. The EU institutions you will visit include the European Commission, the Council of the EU and the European Council and you will have a chance to discuss with those actors who draft, shape and finally take decisions in the European Union. You will continue to have first-hand experience of the EU by visiting various agencies, institutions, and museums in Paris, you will meet French academic experts to discuss French culture, economy, politics and society.

- EU Funds in the Region Trip: South Baden, Germany – 1 day

This day trip will start with a meeting where an expert from the region will introduce you to EU's agricultural and structural funds and their implementation with examples from the region. Following the meeting you will visit a family farm that is typical for South Baden.

- EU Member States Trip - 7 days

Students choose 1 out of the three following course related trip options, e.g.:

1. Stockholm, Sweden; Warsaw, Poland/Prague, Czechia
2. Rome, Italy; Budapest, Hungary
3. Athens, Greece; Sofia, Bulgaria/Bucharest, Romania

The destinations may vary according to the topicality and nature of challenges of the EU and its integration process. The member states of the EU are still characterized by different state structures, economic ideologies, and cultural identities. This last course-related trip gives you the opportunity to choose between three different trip options. On these trips, you will learn about the current challenges of European integration. Experiencing the particularities and cultural diversity of these societies is essential in order to understand the variation in terms of domestic debates and national preferences when it comes to such important issues like, for instance, immigration, macroeconomic integration as well as European security.

Local course-related trips:

Students will participate in two local field trips (each 90 minutes) designed to provide firsthand insight into the practice and implementation of environmental law at the local and regional levels. These visits may include meetings with key stakeholders such as:

- Local politicians
- NGOs (e.g., NABU)
- Forest Research Institute Baden-Württemberg
- Black Forest National Park
- Nature conservation authorities

The first field trip will involve a visit to the **Ökostromgruppe Freiburg**, a company engaged in planning, constructing, and operating wind, solar, and hydropower projects in the greater Freiburg area. The session will focus on how a company integrated the local communities and their concerns within the given environmental legal framework. The second field trip will provide students the opportunity to meet with a representative from the **Sustainability Management Office** of the City of Freiburg. This session will explore the role of local government in shaping and enforcing environmental law and sustainability policies.



The local field trip destinations may vary based on topical relevance and evolving contexts in the field of international environmental law.
