

# HS 358 FRANCE AND THE ATLANTIC WORLD (FROM THE 16TH TO THE 18TH CENTURY)

**IES Abroad Nantes** 

### **DESCRIPTION:**

The purpose of this course is to reflect on the different types of relations between France and the Atlantic area. The overall aim is to examine the particularities of the French presence in the American world from the beginning of the colonial era in the 16th century to relations with the United States at the end of the 18th century. After studying the particular case of New France, we will focus on the Caribbean colonies from an economic and social perspective. This approach will examine the issue of slavery and how it was organized. We will look closely at the role of Nantes in the slave trade to better understand the city as it is today.

#### Homework

The homework is a 5 to 6 page research report on a historical subject dealing with the relations between France and America between the 16th and 18th centuries. The topics are deliberately broad enough to allow each student to focus on the approach that interests them most.

#### Midterm

The midterm will cover the material discussed in class to assess the learning outcome. It consists of questions on specific points, such as vocabulary, concepts, events and geography.

#### **Final exam**

The final examination consists of one global question requiring a well-supported and organized essay response. This will cover the material discussed in class, to evaluate the student's historical reasoning and learning outcome.

#### Attendance and participation

The course is based on interaction between students and the teacher. Students must attend class and complete written and oral assignments. Students will be expected to do their written assignments outside the classroom (reading, written answers, vocabulary research, other research). In class, students are expected to participate in discussions with other students and the teacher. Students should also be fully engaged during written exercises, especially when studying the documents in the textbook.

## LEARNING OUTCOMES:

At the end of the semester students should be able to

- Understand France's role in the formation of colonial America in the 16th and 18th centuries and understand the legacy of its role today

- Understand the important historical processes such as the slave trade and its consequences, particularly in the contemporary French West Indies

- Understand the history of Nantes from the perspective of its Atlantic relations

#### IES ABROAD NANTES ATTENDANCE POLICY:
