



## HS/SO/PO360 SOCIAL PROTESTS IN FRANCE

IES Abroad Nantes

### DESCRIPTION:

This course offers a thematic and chronological exploration of the history of political and social protest in France since 1789, using Nantes as case study, an example, and a focal point. We will analyze the key moments of social struggles, their expressions, and their permanence in the public arena. The work will alternate between national and local scales.

A historical overview will trace the major stages of social struggle, progress, and upheaval since 1789 (political and industrial revolutions, emergence of new social ideas, changing role of the State, trade unionism, etc.). The contemporary stakes and perspectives of societal struggles and recent protests since 1973 (end of the thirty years economic growth period, beginning of the anti-globalization and environmental movements) will be presented, including the relationship between population and State.

This course will use the resources of and collaborate with the CHT (archives of the Centre d'Histoire du Travail de Nantes), and students will be introduced to the methodology of historical research through a study of sources on trade unionism and social conflicts linked to industries in the Nantes region.

### METHOD OF PRESENTATION:

Lectures and discussions based on knowledge input, reading exercises and document commentaries in class and "at home", discussions based on readings and archive viewings.

### REQUIRED WORK AND FORM OF ASSESSMENT:

- Archive study project (written paper) - 30%
- Archive study project oral presentation - 10%
- Midterm - 20%
- Final exam - 25%
- Participation and homework - 10%
- Homework - 5%

### Archive study project and oral presentation

Each student is asked to select, from a list drawn up by the professor, a document or set of documents from the archives held at the CHT (e.g. Nantes trade union press, minutes of congresses or general assemblies of Nantes unions, files compiled by unions during days of action and strikes, etc.). The student will be asked to comment on these using a historical approach. The student's work will be assessed on the basis of a dossier written in French (1750-2000 words / 7-8 pages) and an oral presentation in class (around ten minutes with visual support). Students will be able to work on the CHT's premises.

Methodological approach: The aim is to analyze the document(s) and put its (their) historical interest into perspective with a contribution of scientific knowledge. The approach breaks down into the following stages:

- Search for and select one or more related documents in CHT's archives
- Read and understand the document
- Determine keywords for bibliographic searches based on the nature of the document(s), its author, the historical context in which it was produced, and the themes addressed
- Search for academic bibliographic sources (CHT library, university library, departmental and municipal archives, Bibliothèque nationale de France digitization site, social science journal online repository, etc.).
- Process collected sources in relation to contextualization and analysis of document(s)
- Problematize the document's issues
- Build a detailed plan: introduction, development in two or three parts subdivided into sub-parts, conclusion
- Bibliography with source referencing (French standard ISO 690)
- Present the document(s) context and what is at stake
- Formatting (1750-2000 words of correctly referenced body text + cover page, table of contents, bibliography, appendices)

The work methodology will be presented by the faculty, who will guide and support the students throughout the semester. Brief oral presentations on the progress of each student's research, followed by a short final presentation during the last session, will enable students to share their questions and experiences.

The oral presentation will be assessed based on the clarity and pedagogy of the student presentation and their capacity to respond to questions and foster discussion.

#### **Midterm**

The exam is a classic knowledge-based test based on elements covered in the course and consists of a reflective question or a commentary on a document.

#### **Final Exam**

The exam is a classic knowledge-based test based on elements covered in the course and consists of a reflective question or a commentary on a document.

#### **Participation**

Students are expected to take an active part in lessons by:

- Preparing for class activities by reading materials
- Participating in class discussions
- Preparing questions for field studies and guest speakers

#### **Homework**

- Handing in homework on time.

#### **LEARNING OUTCOMES:**

By the end of the course, students will be able to:

- Explain the main social struggles in French history since 1789 and give examples from Nantes.
- Contextualize the political and social stakes of struggles and social movements in France, and recognize the players involved.
- Describe current societal struggles and recent clashes between demonstrators and police in French public spaces.
- Initiate and produce original historical research based on primary and secondary sources. Reflect and argue on the study conducted.
- Explain how the city of Nantes evolved and how it is unique through the prism of social history.
- Analyze and contextualize demonstrations, strikes, blockades and social movements and their protagonists in their specifically French cultural traits.



#### **ATTENDANCE POLICY:**

Attendance at all IES Abroad Nantes courses is compulsory. Absences may be excused for valid and documented reasons only. In case of absence, students are expected to and responsible for:

- a- Notifying the IES staff and faculty within 24 hours (via email)
- b- Catching up on missed work/assignments
- c- Providing written justification (e.g.: medical certificate)

It is IMPERATIVE that all three conditions listed above be met for any absence to be excused.

NB: Absences due to travel or visits to/from friends or family members will not be excused.

Absences for illness or health reasons (including mental health) without medical justification are tolerated at a maximum of 2 days per semester. You still need to fulfil the above-mentioned obligations a- and b-.

Each unexcused absence will lead to a reduction of your final grade 0.5 /20 (e.g.: 14.5 (A-) will be reduced to 14 (B)) and may also lead to a lower grade for participation. Seven absences in a course will result in an "F" for that course.

Any examination, test, presentation, research paper or any other assignment not completed in time will be marked 0/20. Students who are 15 minutes or more late to an exam (Mid-Term or Final) will not be allowed take the exam and will be marked 0/20 for that exam.

Attendance on field studies is compulsory. In the event that these outings take place at a different time from the class, you will be notified in advance and will be expected to attend the outing. Class excursions may be scheduled on a Friday afternoon.

Faculty have the authority to mark "absent" any student who:

- Arrives 15 minutes or more late
- Leaves the class before it is finished

Multiple and repeated unjustified absences may lead to further disciplinary action and will be subject to an academic review.
